

IMPORTANT INFORMATION ABOUT GRADES AT PROVISO WEST

Beginning with the start of the 2015-2016 school year, Proviso Township High Schools District 209 has implemented updated grading procedures that are designed to provide consistent and clear information about student progress. This flyer provides information to help you better understand your student's grades and how you can stay informed about their progress.

GRADING SCALE

The following grading scales have been implemented with the start of the 2015-2016 school year, with grade point average (GPA) point values reflecting an unweighted GPA:

SEMESTER GRADE CALCULATIONS

Final grades for each semester are calculated as shown below:

- First Quarter of the semester =
40% of semester grade
- Second Quarter of the semester =
40% of semester grade
 - Final Exam =
20% of semester grade



ASSIGNMENT CATEGORIES

Teachers in each department have determined categories appropriate for their subject area so that assignments are given a proper weight in determining a student's grade. For example, tests, quizzes, and major projects tell more about what a student has learned than a daily homework assignment, and will be in higher weighted categories.

RE-DO / RE-TAKE INTERVENTION

This intervention provides the opportunity for students to demonstrate acquisition and mastery of key skills through reengagement of students with critical assignments/ assessments. Student may request no more than three re-do / re-take opportunities per semester of assessments/ assignments determined by the teacher to be key indicators of student learning. Additional opportunities may be allowed at the teacher's discretion.

To be eligible, students must have five or fewer unverified absences per quarter in the class and complete a contract. Quarter and final exams are not eligible for retakes. Students may be required to engage in specific preparation activities prior to the re-do / re-take attempt. The teacher will indicate on the contract the maximum score the student may receive. The contract will also specify the date by which the re-do / re-take must be completed.



NO OPT-OUT INTERVENTION

A student who is in danger of failing primarily due to non-completed or poorly completed assignments may be identified by the teacher for No Opt-Out Intervention. Students will be required to complete the missing assignments to the satisfaction of the teacher to be removed from No Opt-Out Interventions.

While under No Opt-Out Intervention, students will be directed during their lunch period to a specific location in the building to work on the assignment. Students will be given the opportunity to eat lunch, and will then report to the assigned location. The teacher will provide the student with a No Opt-Out Assignment Form. The form will identify the missing assignment, tell the student where to report during their lunch period, and indicate the date by which the assignment must be completed. Once the student completes the assignment, they will no longer be required to attend No Opt-Out during lunch.

If the student does not complete the assignment by the date indicated on the form, a meeting will be scheduled with the student, parents and counselor.



CHECKING YOUR STUDENT'S GRADES

Grades will be updated in PowerSchool by 9 a.m. on Monday each week. It is highly recommended that parents regularly check their student's grades on PowerSchool so that they are able to keep up with their progress.
